AGREEMENT TO WAIVE LIABILITY AND NOT TO SUE

I (for myself, my heirs, family members, personal representatives and assigns) release and discharge the Ninety-Nines, Inc. for the Emerald Angels of the Gulf Coast Section of the Ninety-Nines, Inc., and the officers, directors, members, chapters, employees, agents, divisions, affiliates and volunteers and agree not to sue those named above for any and all claims against any of the above for damages, personal injury or death arising from the person's participation in the EAGC 2019 Poker Run Fundraiser. This release, discharge and agreement not to sue applies to all legal rights, including those resulting from any negligence of those named above, except for gross negligence or willful misconduct of those named above.

ASSUMPTION OF RISK

I understand that flying in airplanes and being around airplanes involves risks. Serious injury or death can result from many causes, including airplane crashes, falls, pilot error, ground crew error, engine or mechanical failure, negligent maintenance, defects in the aircraft, runways, interference by birds and other objects, weather conditions, contaminated fuel, or hard or forced landings. Injuries could be minor such as bruises, scratches and sprains, major such as eye injuries, broken bones and concussions, or catastrophic such as paralysis, severe burns or death. I (for myself, my heirs, family members, personal representatives and assigns) assume all risks and full responsibility for any personal injury or death arising from taking part in the EAGC Poker Run Fundraiser.

INDEMNIFICATION

I and any passengers I choose to bring with me agree to indemnify and hold The Ninety-Nines Inc. harmless from any claims, costs, damages, and liabilities, including attorney's fees, arising from taking part in the 2019 EAGC Poker Run Fundraiser. This duty to indemnify and hold those named above harmless applies even if those named above are negligent, however, indemnification is not required if those named above are grossly negligent or have engaged in willful misconduct.

LEGAL ADVICE

I know that I can talk to my legal advisor about this Agreement and I have either done so or chosen not to. I understand that I have the right and have been given the opportunity to object to and bargain about the provisions of this Agreement. I am voluntarily signing this Agreement and intend it to be the unconditional release of all liability to the greatest extent allowed by law. Before signing, Carefully Read this Entire Agreement: If an accident were to occur, you and any passenger (by signing this Agreement) would be giving up legal rights and incurring legal liabilities. If any part of this Agreement is held invalid, the rest of the provisions shall remain in effect. If you do not understand anything in this Agreement, you should not sign it and you should talk to your legal advisor.

Furthermore, the undersigned acknowledges that this event is NOT a race, challenge, match, or test of skill. Participants must be at least 18 years of age and must hold a valid driver's license or pilot's certificate dependent upon the mode of transportation.
